Spectrum

Affordable Connectivity Program (ACP)

Dear Spectrum Customer,

It's our pleasure to assist you. Here's some follow-up information we think you'll find useful after our recent discussion.

The <u>Affordable Connectivity Program</u> offers accepted households a monthly credit to help pay for internet service. You can receive a credit of up to \$30 per month toward your internet service, or of up to \$75 if your household is on Tribal lands.

Please visit the <u>FCC National Verifier website</u> to find a complete list of eligibility criteria for the Affordable Connectivity Program. If you're eligible, here's how to enroll:

- Complete your application on the <u>FCC National Verifier website</u>. You may receive immediate approval however, if your eligibility can't be confirmed automatically, you'll receive a request for additional documentation.
 - Once you're approved, go to the <u>Spectrum online form</u> to finish your application. It's important to complete both the FCC National Verifier form and the Spectrum online form.
- After you've submitted your Spectrum application, you'll receive updates by email. Updates may include information such as your application status, approval confirmation and what to expect on your bill.

Note: The personal information you provide on the FCC website and the Spectrum application must match exactly. For example, if you used "Liz" as your first name on the FCC National Verifier, don't use your full first name "Elizabeth" in the Spectrum application.

View instructions and other resources to help you receive your ACP benefit.

If you need to talk to someone about your application status, eligibility documents, local participating companies, assistance with the ACP Household Worksheet or resetting your account, call the FCC ACP Support Center at (877) 384-2575, 7 days a week, from 9:00 am to 9:00 pm ET. You can also email support at <u>ACPInfo@fcc.gov</u>.

Winter Crisis Program

The Ohio Development Services Agency and Clinton County Community Action Program will help income-eligible Ohioans stay warm through the winter months. The Home Energy Assistance Winter Crisis Program provides a benefit once per heating season to an income-eligible Ohioan's main heating accounts. Client can apply in person at Community Action, 789 North Nelson Avenue, Wilmington, OH. Eligible clients are those at or below 175% of the Federal Poverty Guideline that are disconnected (or have a pending disconnection notice), need to establish new service, need to pay to transfer service, or have 25% or less bulk fuel supply remaining. The program can also assist in fuel tank replacements, fuel tank testing and heating system repairs. The program operates from November 1, 2023 to March 31, 2024.

Applicants will need to bring the following documents with them to visit:

- Copies of most current heating AND electric bills
- Proof of income for past 30 days, if self-employed or seasonal will need 12 months income and <u>complete</u> IRS 1040 documents. If you have no income, please contact the office for further instructions.
 - Birth Certificate or Social Security Cards for all household members

*PIPP (Percentage of Income Payment Plan) Applications are currently being accepted.

*HEAP (Home Energy Assistance Program) Applications are currently being accepted through 5/31/2024.

Medicare Open Enrollment season is right around the corner, which also brings out scammers and their tricks to obtain personal information.

A common tactic during Open Enrollment is to create confusion about Medicare cards. A representative from "Medicare" calls older adults to tell them they are eligible for a new Medicare card. All they need to do is verify their personal information.

Medicare fraud is a billion-dollar business. Scammers are friendly. Personable. Knowledgeable. They create rapport and trust with people answering the phone. Then they apply pressure and often obtain personal information that should never be shared on the phone.

Medicare is not issuing new cards this year. The caller from "Medicare" is a scammer.

We at the Ohio Senior Medicare Patrol hear stories from older adults who have answered the phone and believe that Medicare is on the other end. Or Social Security. Or the Internal Revenue Service. It's not. These trusted government agencies will not initiate calls.*

Con artists are opportunists and target us in times of transition or change. Medicare Open Enrollment is one of those times of transition, which means phones will likely start ringing more often with offers of new cards, new programs, and new services. Know this – Medicare is not calling. I want to make sure that everyone knows that! Medicare is not calling! Medicare will not call.*

Please help keep seniors in your network safe from scams by warning them that they may get calls about a new Medicare card – and if so, hang up! Remind them to never give out personal information, especially Medicare card numbers or Social Security numbers. Even better – advise them to screen all calls and decline or send to voicemail calls that are not in their verified caller lists.

If you know anyone who has mistakenly given out their Medicare number to a caller, let us know. We can help check their Medicare account for suspected fraud and help to get it resolved.

*Note that trusted government agencies will never initiate a call, but they may call back if requested.






